- 6. November 2022 to December 2023.

Therefore, I'd like to make a request under the Freedom of Information Act for all of the South Yorkshire Police's transactions over £500 for the above time periods.

Please provide the data in a machine readable format (preferably csv). As a minimum, please make sure to include the date, value and recipient of each transaction. Please also provide details on the procurement category of each transaction if you have it.

RESPONSE

Section 1 of the Freedom of Information Act 2000 provides two distinct but related rights of access to information, which impose corresponding duties on public authorities. These are:

- Section 1(1)(a) the duty to inform the applicant whether or not information is held by the authority, and if so,
- Section 1(1)(b) the duty to communicate that information to the applicant.

The Office of the Police and Crime Commissioner (OPCC) does hold some information in relation to your request but not all.

Attached in the folder is the following data:

No information is held for South Yorkshire Police for May, June, September, October and November 2016.

Data for October, November and December 2023 will be available on the PCC's website in the next few weeks. Taking this into consideration, this response is a partial response, and I will send you the missing data as soon as this is available.

Neither the OPCC nor SYP produce data in CSV. Freedom of Information guidance states that, say "If you don't hold a particular piece of information that someone has asked for, you don't have to create it. Nor are you required to ask a third party for the information, unless they hold it on your behalf." Where available the information has been provided in Excel.
