This closure was high profile, along with the changes to Neighbourhood policing in the last force restructure. The station has not been public access for many years. Neighbourhood teams, including a dedicated Dinnington Police Now recruit, are widely known at the Dinnington Resource Centre, with regular advertised public surgeries. Support from this local team come from Maltby Police Station, where the wider Neighbourhood Team is based. Response policing has been from Maltby for many years. The majority of the community are accepting that South Yorkshire Police has to cut costs and become more efficient with its buildings. There is a small but vociferous campaign to re-open the police station and this remains.
