Proposed activities must address one or more of the Commissioner strategic priorities as set out in the Police & Crime Plan. Funded organisations have to show compliance with Terms & Conditions including the submission of monitoring Information at agreed milestones.</p> <p>Officers have considered and assessed 4 applications for funding with a total value of £19,369.21 and recommend that 2 applications be approved at this time. There will be opportunities in the remainder for the financial year for other applications / reapplications to be considered.</p> <p>A meeting was held on the 22nd August 2019 with the PCC to discuss the applications. The panel recommendations were considered and a decision made to fund as agreed by the Panel</p> <p>2 bids were agreed to be funded with a total value of £9881.21.</p> | | |
